

# Safe Agent Redirection Service

## Re-Direction Service Agreement

### 1. Service

- 1.1. By agreeing to this agreement you agree to Safe Agent Ltd generating traffic to your specified website and you agree to the terms contained within this agreement and any applicable agreements, policies or procedures posted on the Safe Agent website, as well as changes that may be made to them; including relevant rules, requirements and policies.
- 1.2. Safe Agent Ltd will use a multitude of services to generate traffic to your website which may include:
  - 1.2.1. Creating local web pages,
  - 1.2.2. Registering local domain names,
  - 1.2.3. Utilising local search engines,
  - 1.2.3. Add information to local blog sites,
  - 1.2.4. Add information to local forums, and
  - 1.2.5. Any other service we feel required to generate traffic
- 1.3. The redirection Service will be subject to an annual subscription fee of \$800 per year (USD)
- 1.4. All relevant service fees encountered by Safe Agent to generate traffic will be Safe Agent's sole responsibility. Safe Agent will possess all ownership rights, which will not be conferred on to you.
- 1.5. Safe Agent will, within its power, ensure that no traffic will be generated through illegal or morally questionable activities (e.g. pornography, terrorism etc).
- 1.6. Upon subscription you will be required to specify a URL for the redirection service.
- 1.7. Subscription services are paid in advance and once service has commenced you are not entitled to a refund.
- 1.8. The Safe Agent Redirection service is currently only available, at this time; in countries whose first language is English (e.g. United States, United Kingdom, Ireland, Australia, New Zealand etc).

### 2. Term

- 2.1. The subscription service shall last for one year. You will be invited to renew your subscription to the Redirection Service for a further year.

### 3. Termination and Modification

- 3.1. We reserve the right at any time and from time to time to:
  - 3.1.1. modify these Terms (or any part thereof); and
  - 3.1.2. revise the content of our Safe Agent Website (including our Services): temporarily or permanently, with or without notice.
- 3.2. We will take reasonable steps to bring to our customers' attention changes to these Terms. Any changes shall be binding and effective on you when you click acceptance of our Terms after they have been altered and posted on our Website. Please check our Website frequently. In addition, specific Services or information contained within our Website may be subject to additional posted Terms or guidelines applicable to such Services. All such Terms or guidelines are hereby incorporated by reference into these Terms.
- 3.3. If you continue to use our Services after any changes take effect, you will be taken to have accepted these changes and so be bound by them.
- 3.4. You or we may terminate this agreement (as regards some or all of the Services) immediately on written notice to the other.
- 3.5. We may also terminate the Re-Direction Service immediately on written notice if:
  - 3.5.1 you commit a material breach of any of these Terms and in particular upon any failure

3.7.3 any rights that have accrued to either party at the date of termination and clauses in these Terms which are expressed or intended to survive the termination of these Terms shall survive and remain enforceable after termination.

3.8. In the event that you have terminated the agreement under paragraph 3.4 Safe Agent will give you first priority to take over any services Safe Agent used in the generation of traffic for your website ("Service Transfer").

3.9. Paragraph 3.8 is subject to rules and procedures of services where applicable. The "Service Transfer" facility has a fee of US\$199

3.10. You agree that we shall not be liable to you or to any third party for any modification, suspension or discontinuance of the service.

## 4. Data

4.1. At any time upon written request Safe Agent will provide all sources and details of Services utilised to generate traffic.

## 5. English law and jurisdiction

5.1. This agreement is governed by English law and is subject to the exclusive jurisdiction of the courts of England & Wales.
